

PRIVACY POLICY

This Privacy Policy discloses the privacy practices for mobile games owned by Forever Young Studio and websites and applications related to our mobile games (collectively referred to as the “Forever Young Studio Games (FYSG)”. For the purposes of this privacy policy, unless otherwise noted, all references to “Forever Young Studio Games” include the following products:

The FYSG Services may contain links to other websites for your convenience and information. We are not responsible for the privacy practices or content of those sites.

NOTE TO KIDS

Forever Young Studio Games are not for persons under the age of 13. If you are under 13 years of age, then we encourage you to visit other games or to seek for adult’s supervision.

NEVER DISPLAY ANY PERSONAL INFORMATION THAT COULD BE USED TO FIND YOU IN THE REAL, OFF-LINE, WORLD -- for example, your full real name, mailing or home address, or phone numbers.

What information do we gather about you?

The information Forever Young Studio Games gathers falls into two categories:

- 1) personal information that you supply and
- 2) non-personal information collected through technology, which includes tracking information as you use FYSG Services.

Personal information that you give us

- **Registration.** Our games do not require registration and thus we do not gather and store any personal information.
- **Facebook Connect.** You may choose to log in to Facebook Connect in our game upgrades. By doing this, you are asking Facebook to send us certain information from your Facebook profile, and you authorize us to collect, store, and use in accordance with this Privacy Policy any and all information available to us through the Facebook interface.
- **Customer Service.** You may submit a customer service inquiry revealing your email address and name.

Non-personal information collected using technology

- **Device Information.** We may collect non-personal information about the mobile device you use to play our games such as IP address, geolocation information, unique device identification, operating system, and device model.
- **Analytics Technology.** We have hired third parties to provide us information, reports, and analysis about the usage and browsing patterns of users of Forever Young Studio Games. These third parties may independently record the type of device and operating system you are using, general location information, as well as events that occur within our games, such as how often you play our games. We do not receive that information.

Information collected by third parties using technology

Some of the services and advertisements included in Forever Young Studio Mobile Games are delivered or served by third-party companies. We do not have access to, nor control over, advertisers' or service providers' use of tracking technologies or how they may be used. With whom do we share the information that we gather?

We will not sell, rent, swap, or authorize any third-party to use your information that personally identifies you without your permission. We share information about our audience in aggregate or de-identified form. Nothing in this Privacy Policy is intended to restrict Forever Young Studio Games's use of aggregate or de-identified information in any way.

In the future, we may sell, buy, merge, or partner with other companies or businesses. In such transactions, we may include your information among the transferred assets.

Service Providers

We contract with other companies to provide services on our behalf, including analytics and promotions management. We provide these companies only with the information they need to perform their services. These service providers are restricted from using this data in any way other than to provide services for Forever Young Studio Games, and they may not share, resell, or use the data for their own direct marketing purposes.

Is my information protected?

To prevent unauthorized access, maintain data accuracy, and ensure the appropriate use of information, we have put in place commercially reasonable physical, technical, and administrative controls to protect the information. We may disclose personal information if we are required to do so by law or we have a good faith belief that such action is necessary to

- 1) comply with the law or with legal process,
- 2) protect and defend our rights and property,

- 4) protect the personal safety or property of our users or the public (among other things, this means that if you provide false information or attempt to pose as someone else, information about you may be disclosed as part of any investigation into your actions).

Our Commitment to Children's Privacy

Some features of the game being associated with in-Application purchases, a parent or guardian must at all-time properly supervise any children under 13 years of age.
